Candidate must complete a CFP-board registered program, or hold one of the following:

- CPA
- ChFC
- Chartered Life Underwriter (CLU)
- CFA
- Ph.D. in business or economics
- Doctor of Business Administration
- Attorney's License

Examination Type: CFP Certification Examination

Work Experience: 3 years of full-time relevant personal financial planning.

Continuing Education: 30 hours every 2 years

#### **CPA – Certified Public Accountant**

Issued by: The State of Florida Board of Accountancy

Prerequisites/Experience Required:

Educational Requirements: 150 semester hours or 200 quarter hours total including 36 semester hours or 54 quarter hours of upper division accounting classes and 39 semester hours or 58 quarter hours of upper division general business classes.

Examination Type: Pass a comprehensive 4-part exam.

Work Experience: One year of work experience under the supervision of a licensed CPA.

Continuing Education Requirements: 80 hours of continuing professional education every two years.

#### **PFS – Personal Financial Specialist**

Issued by: The American Institute of Certified Public Accountants

Prerequisites/Experience Required:

Prerequisite: Must hold a valid and unrevoked CPA license issued by a legally constituted state authority.



Education Requirements: A minimum of 75 hours of personal financial planning education.

Examination Type: Pass one of the following Personal Financial Planning related exams:

- Personal Financial Specialist Exam
- Certified Financial Planner Exam
- Chartered Financial Consultant Exam

Work Experience: 2 years (3,000 hours) of full-time business or teaching experience in personal financial planning.

Continuing Education: 60 hours of personal financial planning education every 3 years.

Additional Requirements: PFS holders, as members of the American Institute of Certified Public Accountants (AICPA), are required to follow a rigorous *Code Of Professional Conduct* which requires that they act with integrity, objectivity, due care, competence, fully disclose any conflicts of interest (and obtain client consent if a conflict exists), maintain client confidentiality, disclose to the client any commission or referral fees, and serve the public interest when providing financial services.

A PFS credential holder is also required to adhere to the *Statement on Standards in Personal Financial Planning Services*, when providing financial planning services.
